#### D. Reports:

- 1. Chair Report by Chair Sam Cradduck:
  - a. Brittany is working on a calendar plugin with clickable links to flyers. The desired functionality is for users to click on a calendar event and be directed to a PDF flyer.
  - b. Minutes to be sent out within a week after the meetings going forward (Brittany will handle this).
  - c. Website updates are in progress; Brittany is working on adding a calendar flyer section with clickable links.

#### 3. Senior Information and Assistance Report - Karen Costeines

- a. Thank you for the United Way housing specialist speaker.
- b. Farmers Market Coupon Books Distribution:
  - Victor Valley College Farmers Market (Lower Campus): July 17th,
     9am-12pm, first-come, first-served.

- Phelan's Farmers Market: July 21st, 2pm-4pm, first-come, first-served.
- Pre-registered individuals will be served first.
- Seniors need to qualify based on household size and income (similar to HEAP requirements). A one-person household can qualify if their income is \$3170 per month or less.
- Coupon books are \$50 and can be used for fruits, vegetables, and honey.
- Please use all the coupons by the expiration date.
- c. AAA (Area Agency on Aging) surveys are available with self-addressed, postage-paid envelopes. Karen has 10 English and 5 Spanish surveys.
- d. Action Item: Karen to Speak on basic services and programs and transportation.

  - a. The Board of Supervisors approved contracts for senior support services:
    - Victor Valley Community Services Council.
    - Unique Adult Day Home Care.
    - ICRC (transportation, residential repairs, activities).
    - Inland County Legal Services (senior legal services, \$350k).
    - Family Caregiver Support Program Services (countywide ICRC,
       New Grace Family Care LLC, Envision Spanish).

- Need to give seniors bus passes as soon as possible after inventory.
- Discussion on potential Medicaid cuts and impact on senior services.
   Concern about the future of senior support and the need for creative solutions.
- Importance of supporting unpaid family caregivers. Support and teach families what their family member is going through. 30% of family caregivers die before the person they're caring for.
- Discussion on Medicare waivers, specifically for assisted living. If the waivers are depleted, where are people going to live?
- Discuss sharing care costs and shared rent.
